## Minutes of

Tengizchevroil LLP Future Growth Project -Wellhead Pressure Management Project

## **Consultation Meeting**

**Venue:** Community Centre, Koschagyl village, Zhylyoi District of Atyrau oblast

Date & Time: October 10, 2018

10:00 - 11:30

**Basselov S, the Akim of Koschagyl village**, started the event and welcomed the residents, and then announced that Tengizchevroil LLP (TCO) was going to provide information on the Future Growth Project - Wellhead Pressure Management Project (FGP-WPMP). He then handed the floor to R. Artygaliev.

R. Artygaliev, TCO General Manager, Policy, Government and Public Affairs, informed participants that TCO continues holding annual consultation meetings with Atyrau Oblast Community. The objective of the meeting was stated, which was to give an overview on work progress within TCO FGP - WPMP and listen to the audience opinion regarding TCO and Project. He emphasised that the consultation meeting was not a public hearing. It was stated, that presentation about the Project would be introduced followed by Q&A Session, and if attendees would like to address their requests in written form, they could use special forms provided to each attendee. R. Artygaliev noted that in case of any further queries the attendees could address TCO by the contact information provided in handouts distributed to all the meeting participants.

It was emphasized by R. Artygaliev, that TCO contacted to all attendees who addressed written requests on previous meeting and provided answers to their questions.

Further, as per the agenda, Nurtas Kenganov, FGP-WPMP Regulatory Affairs Manager, delivered a presentation on TCO and FGP-WPMP activities.

R. Artygaliev informed the community on the status of sports centre construction project in Koschagyl village. It was advised that in 2017 the Akimat of Atyrau Oblast has excluded this Project from the List of Projects implemented under the "Egilik" Social Program. However recently the sports centre construction project was incorporated to the program again. Currently the documentation required for sports centre construction is being prepared.

Then the Q&A Session started.

**A. Baizhumiyev:** Is there a plan for construction of the second kindergarten? The one completed is designed for 160 children, while 400 kids are currently on the waiting list. What is the procedure to collect construction wastes from Tengiz? We did face some difficulties with disposition. We were told that specially designated trucks were required.

- **R. Artygaliev (TCO):** TCO cannot assist with trucks, please address this to the Akimat. You can proceed with wastes disposition during the weekend, as well. Please approach our representatives after the meeting, and they will assist with coordination of shipments. Regarding the construction of the kindergarten, please submit the request to the Akimat of Atyrau Oblast through the Akimat of Zhylyoi District so to have this included into the "Egilik" Social Program.
- S. Basselov (Akimat): Akimat can provide truck to the residents during the weekend.
- **S. Basselov (Akimat):** We ask for your help with clearing of the road from Koschagyl to Tengiz. Akimat has the Company providing road clearing services. Can TCO contract this Company?
- **R. Artygaliev (TCO):** We will review this request and inform on the decision.
- **S. Basselov (Akimat):** TCO has planted around 70 thousand transplants in Tengiz. How many of them did take roots?
- **G. Sharipova (TCO):** Only 2% 1,500 transplants.
- **R. Artygaliev (TCO):** Due to the soil features, trees do not grow in Tengiz. TCO will provide the transplants to the Akimat of Zhylyoi District for planting within the communities' envelopes. We are now waiting for endorsements of authorized agencies.
- **S. Basselov (Akimat):** Will technical water be supplied during the next year? Installation of large diameter pipes is ongoing, what benefit will be produced for the community? Will there be right of way left for our village?
- **R. Artygaliev (TCO):** TCO will continue with water supply to the village of Koschagyl. But as before, there will be some water supply shutdowns due to technical reasons.
- **S. Basselov (Akimat):** We ask for your assistance with installation of the technical water reservoir, and this will enable uninterrupted water supply for population.
- **R. Artygaliev (TCO):** We will review your request. But we ask you to submit this request to the Akimat of Atyrau Oblast to be considered for inclusion of this project to "Egilik" Program.
- **Zh. Satybaldiyev:** Youth of the district is facing difficulties with employment. The work in Contractors' organizations for a couple of months and then get dismissed for redundancy reasons. Does TCO hire young specialist?
- **K. Joldasbayev (TCO):** TCO vacancies are posted in Career section on TCO website. CVs are accepted in electronic format only. All data required must be provided during application process. Otherwise, your application will not be accepted for consideration. The Project contractors publish available vacancies on ENBEK.KZ web-portal. Applicants need to register on the web-portal, monitor the job openings and apply for suitable jobs to get employed on FGP-WPMP project.

## Conclusion

R. Artygaliev thanked the residents for participation and noted that consultation meetings with the community will be arranged every year until the completion of the project.
