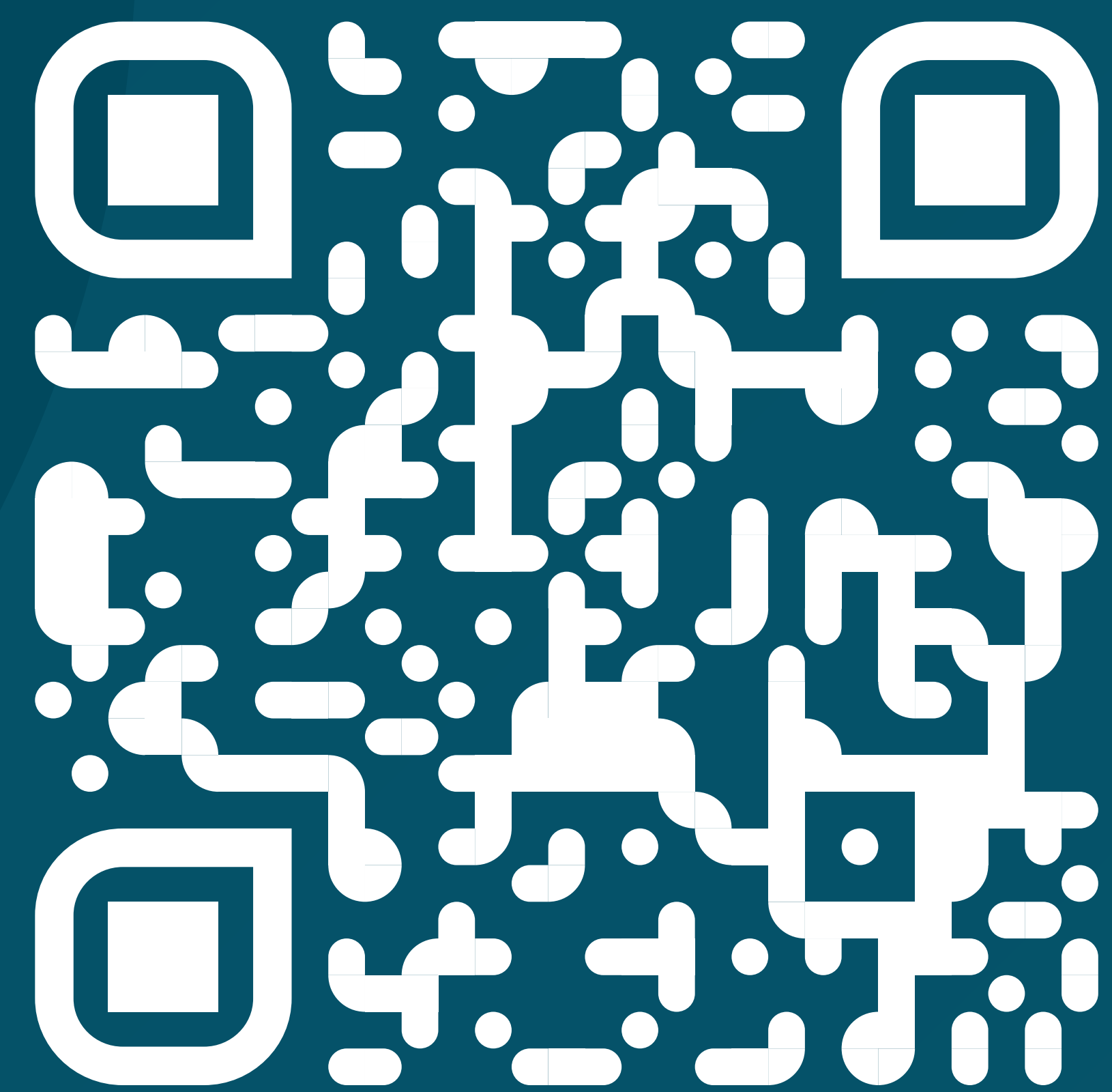


What is SEOI?

KEY REGISTRATION STEPS

CREATING AN SEOI ACCOUNT

1. Go to the seoi.tengizchevroil.com portal
2. Click the “Create Account” button

COMPLETING THE COMPANY PROFILE

1. Legal company name and legal form
2. Registration details (BIN/IIN, address)
3. Contact details of responsible persons
4. Information about experience and capabilities
5. All required fields shall be completed

SELECTING PRODUCT/SERVICE CATEGORIES

1. Specify the goods, works, or services
2. Select the codes and categories from the list
3. 10 categories per company at most

UPLOADING DOCUMENTS

1. Certificate of company registration
2. Business licenses
3. Certificates of conformity
4. All documents shall be uploaded exclusively through the SEOI portal

SUBMITTING THE PROFILE

1. Click the “Submit” button
2. Receive confirmation of registration
3. Status: “Registered” (valid for 1 year)
